The <u>SSU Staff Council</u> encourages all staff (non-faculty employees) to consider participating in shared governance by serving on the Staff Council Executive Committee, the Academic Senate, and/or a university-wide committee or working group.

The Staff Council Executive Committee appoints or elects staff annually aligned with the academic calendar (August - May) and prefers 2-year terms when possible. We recommend you obtain supervisory approval prior to running for a position or requesting an appointment. Please note that currently serving on a university committee does not preclude you from serving on additional committees. Staff are also welcome to serve multiple terms on a committee unless otherwise noted.

ACADEMIC MASTER PLAN WORKING GROUPS

• The Treasurer shall:

Be responsible for all money acquired by Staff Council; Pay all bills; Assist the Chair in the preparation of the proposed annual budget; Perform other duties as may be deemed necessary and assigned by the Chair.

• The Custodian of Records shall:

Be responsible for Staff Council correspondence and web presence. Notify officers/members of their election; Maintain current officer roster; perform other duties as may be deemed necessary and assigned by the Chair.
